Photo Release: I grant Jameson Camp staff and persons acting through them, the right to use, reproduce, assign, and/or distribute photographs, films, videotapes, and sound recordings of my child or myself for use in materials they may create.

I and my child (collectively "I" and "my") understand that my participation in programs offered at Jameson Camp is completely voluntary. I recognize that the Program may include many different types of activities and events focused on skill-building and personal or interpersonal enrichment, but that my participation is purely voluntary. At all times, I will choose my level of participation in any activity.

I understand that the program may include, but may not be limited to, the following activities in which I/my child may enroll: swimming, archery, arts and crafts, outdoor education, culinary arts, camping, performing arts, and recreation. I understand that there are certain dangers, hazards, and risks inherent in these and all other activities in the Program, and that I/my child's participation may involve risk of injury and loss, both to person and to property. I also understand that the risk of injury may include the possibility of permanent disability and death. I elect to participate in spite of these risks. I knowingly and voluntarily assume all risks involved in my participation.

In consideration of my/my child's participation in the Program, I, for myself/my child, and my heirs, executors, administrators, successors and assigns, hereby RELEASE and forever DISCHARGE Jameson Camp, and its successors, assigns, agents, independent contractors, officers, directors, staff, employees, and attorneys, both individually and in their representative capacities (collectively, the "Jameson Released Parties"), from any and all claims, demands, rights of action or liabilities of whatsoever nature, whether known or unknown, which I had, now have, may have or might in the future have against the Jameson Released Parties, including but not limited to, any and all claims, demands, rights of action or liabilities based upon any NEGLIGENCE on the part of the Jameson Released Parties based upon, arising out of, or in any manner connected with my participation in the Program.

Furthermore, in consideration of my participation in the Program, I hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the Jameson Released Parties from any and all claims, demands, rights of action or liabilities of whatsoever nature (including bodily or psychological injury, loss of life or personal property and attorneys' fees) that any person had, now has, may have or might in the future have against the Jameson Released Parties, including but not limited to, any and all claims, demands, rights of action or liabilities based upon any NEGLIGENCE on the part of the Jameson Released Parties based upon, arising out of, or in any manner connected with my/my child's participation in the Program.

I HAVE READ THIS ENTIRE RELEASE FROM LIABILITY AND INDEMNIFICATION AGREEMENT AND HAVE SO INDICATED BY SIGNING BELOW. I UNDERSTAND THAT THERE ARE MANY DIFFERENT AND UNAVOIDABLE RISKS INVOLVED IN PARTICIPATION IN THE PROGRAM, AND I AM RELEASING THE JAMESON RELEASED PARTIES FROM ANY AND ALL CLAIMS AND LIABILITIES (INCLUDING ATTORNEYS' FEES) ARISING OUT OF MY PARTICIPATION IN THE PROGRAM, INCLUDING ANY AND ALL SUCH CLAIMS AND LIABILITIES BASED UPON ANY NEGLIGENCE ON THE PART OF THE JAMESON RELEASED PARTIES.

I FURTHER UNDERSTAND THAT I HAVE AGREED TO INDEMNIFY AND HOLD HARMLESS THE JAMESON RELEASED PARTIES FOR ANY AND ALL CLAIMS OF ANY PERSON OR ENTITY ARISING OUT OF MY/MY CHILD'S PARTICIPATION IN THE PROGRAM, INCLUDING ANY AND ALL CLAIMS AND LIABILITIES BASED ON ANY NEGLIGENCE ON THE PART OF THE JAMESON RELEASED PARTIES.

I have read, understand, and accept the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon me/my child during the entire period of participation in the Program.
